In following recent news stories concerning University of Missouri employees and their applicable employee policies relating to campaigning for public office has me interested in obtaining the following information for a better understanding of my initial concerns. Please provide me responses to the following requests.

All emails or documents sent to or from Stephen Owens, or anyone on his behalf, relating to the granting of tenure or granting of leave of absence for any professor or associate professor for the time period dating back 3 years from today.

A copy of the policy used to determine if a professor or associate professor is teaching the expected amount of classroom hours per semester or academic year. This document or policy may commonly be referred to as the Teaching Expectation Requirement.

The number of professors or associate professors currently employed at the University of Missouri-Columbia who have received a waiver, at any point, from the Teaching Expectation Requirement. For this request, I would like the data dating back 5 years from today.

The average number of hour's professors at the University of Missouri spent in class room teaching for the 2014-2015 academic school year.
